

XXL Absorb Pizza Party Promotion - Full Terms & Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry instructions are deemed to form part of these Terms and Conditions and by participating all entrants will be deemed to have accepted and be bound by these Terms and Conditions. Please retain a copy for your information.

1. **The Promoter and data controller:** This promotion is operated by Sofidel UK LTD, Briton Ferry Industrial Estate, Neath, SA11 2FP.
2. **Eligibility:** The promotion is open to residents of the UK (England, Scotland, Wales, and Northern Ireland) and Republic of Ireland, aged 18 or over, excluding employees of the Promoter and its holding companies and subsidiaries and their immediate families; its agents and suppliers and anyone else professionally connected with this promotion.
3. **Promotional Period:** Opens 00:00:01 BST on 22nd July 2024 and closes 23:59:59 BST inclusive on 15th September 2024. Any entries received before or after this time will not be included in the promotion.
4. Internet access and registration required.
5. Purchase of promotional pack necessary and there is no charge to access or enter on the website.
6. Entry is restricted to one entry per person, per purchase. For the avoidance of doubt, a winner can win multiple online instant win prizes and the grand prize.
7. **Entry Instructions:** To participate, entrants must purchase a 2-roll promotional pack of XXL Absorb in store or online at participating retailers during the Promotional Period, then also during the Promotional Period visit winabsorb.regina.uk.com, select whether they are a resident of the United Kingdom or the Republic of Ireland, enter the unique code found inside the pack, as well as their full name, email address, date of birth, delivery address (United Kingdom entrants only), accept the terms and conditions and submit their entry to find out instantly if they have won a prize. For every entry submitted, an entry will also be made into the grand prize draw. There will also be an optional marketing opt-in box. Packs are subject to availability and whilst stocks last.
8. Each promotional code is unique and can only be used once. Any attempts to enter the same code more than once, use codes from non-promotional packs, or the use of any codes not intended for use in this promotion, may result in disqualification and all such entries will be declared void.
9. Proof of sending or transmission will not be accepted as proof of delivery.
